CHILD WELFARE COMMITTEE, COIMBATORE

It is constituted as per Section 29 of Juvenile Justice (Care and Protection of Children) Act 2000. This committee is dealing with cases pertaining to the children in need of care and protection. It has jurisdiction over Coimbatore and Nilgiris Districts. This committee consists of one Chairman and four members, one of them shall be a Women. All of them are conferred with the powers of Judicial First Class Magistrate. The present child welfare committee was constituted as per G.O. No. 124 Social Welfare, N.M.P. Dept. dated 29.6.2007. It is functioning from 01.07.2007. The Chairman and Members would hold this office for a period of three years from the date of appointment. At present the place of sitting of this committee is at Observation Home for boys and girls premises at No. 1093, 94, Avanashi Road, Pappanaickenpalayam, Coimbatore -37. The committee is sitting thrice a week on Tuesday, Thursday and Friday from 2.00 PM to 5.00 PM. For these sittings the Chairman gets a honorarium of Rs. 2000/- per month and members are paid Rs. 1,500/- per month.
